Mashed Sweet Potatoes with Honey and Ginger

Ingredients

- 5 lbs. sweet potatoes
- 1/2 stick butter (1/4 cup)
- 3 Tbsp. honey
- 1 1/2 tsp. grated fresh ginger
- 3/4 tsp. each salt and pepper
- Chopped parsley (for garnish)

Directions

1. Heat oven to 400 degrees. Pierce each potato one with a fork and place in jelly-roll pan.
 2. Bake 50 minutes to 1 1/4 hours until very tender.
 3. When cool, split and scrape pulp into a large bowl.
 4. Add remaining ingredients; mash until smooth.
 5. Spoon into serving bowl; garnish with parsley.
- Makes 12 servings.*

Bonnie's Best Caramels

Ingredients

- 1 pint half and half
- 1/2 pint whipping cream
- 1 bottle light corn syrup
- 4 cups sugar

Directions

1. Combine half and half and cream.
2. Combine one cup of half and half/cream mixture with remaining ingredients in a large pan such as a Dutch oven. Bring to a boil to soft ball stage.
3. Add one half pint of half and half/cream mixture and bring to soft ball stage again.
4. Add remaining half pint of mixture and bring to soft ball stage. Don't go past soft ball stage the third time.
5. Pour into buttered 9x13 pan and refrigerate several hours.
6. Cut into pieces of desired size and wrap in waxed paper.

A car accident in Kentucky sent a 70-year-old Ohio woman to the hospital. She suffered a fractured pelvis and had to have a portion of her lower bowels removed. She was taken via ambulance from Kentucky back up to Ohio and is now a resident in a rehabilitation hospital program.

A pregnant mother was involved in an accident and lost her unborn child. She and two of her sons were passengers in a car that ran a red light and crashed. The sons suffered minor injuries; one is still treating for a knee injury. The mother, who also suffered a collapsed lung, was Life-Flighted from the scene.

A Virginia car accident caused injury to a female passenger in the vehicle. She suffered a broken wrist and pinkie and was taken from the scene to the hospital via EMS. She will have to consult with an orthopedic surgeon in Toledo.

Lawsuits Filed on Behalf Of Two Firm Clients

was a resident at Marria's Adult Family Home. On Dec. 14, 2009, police were summoned there because Ms. Hicks was reported to be agitated and holding a pair of craft scissors in her room.

responded to the scene. Staff at Marria's Adult Family Home allowed the officers to approach Ms. Hicks with weapons drawn.

After being Tasered twice while laying in her bed, Ms. Hicks got up and approached the officers. Officer Chandler proceeded to shoot and kill Ms. Hicks.

Six weeks later, Mr. Lewis was a passenger in a car that was, without his knowledge, stolen. Police gave chase to the vehicle, and the driver fled and crashed.

Mr. Lewis exited the car and proceeded on foot. A police cruiser followed him and pulled into a driveway, blocking his path. Mr. Lewis stopped in the driveway and put his hands up.

Officer Chandler, in her police cruiser, turned into the driveway and struck Mr. Lewis. Witnesses said she made no attempt to avoid him or slow down. He was thrown into the air and was transported from the scene by LifeSquad.

Both of the incidents addressed in the lawsuits were completely avoidable, and the attorneys in our office will do everything they can to make things right.

Hunting Injury Case Settles for \$350,000

A client of the Charles E. Boyk Law Offices recently saw his case settle for \$350,000. Our client was injured while out hunting with some friends. His companion's gun accidentally discharged, and our client was shot in his ankle. The shot took out his Achilles' tendon and shattered his ankle and heel.

Following his injury, our client endured four surgeries. These removed bone fragments and put plates into his foot. He now has to wear a brace, can't walk over uneven surfaces and can't carry more than 20 pounds of weight.

With his medical costs covered, our client was able to use some of his settlement to take care of other financial obligations. And even though his injury was a painful experience both physically and emotionally, he says he was glad it allowed him the opportunity to spend more time with his children.

Although his case was not necessarily an example of a typical settlement, our office was happy to be able to assist our client in getting the compensation he deserved following his accident.
