- S = Ride Sober**

- A = Ride Alert**
- R = Riding Gear**





CASES OF INTEREST: APRIL 2012

YOUNG CHILD BITTEN BY A VIZSLA

Our client was over at a family member's home when she was bitten by a dog called a Vizsla. A Vizsla is a Hungarian hunting dog. Even though they are a hunting dog they are known to be kind, loving and gentle to those around them. Everyone in the house heard the nip and bark from the dog then all of a sudden heard our client crying. She was taken to an Indiana hospital for evaluation and stitches. Our client not only had to have stitches but also had to treat for an infection from the wound. The family is now contemplating plastic surgery to take care of the scar that is now on her face forever. Scars are permanent and surgery can lessen their severity but cannot eliminate them.

INJURED ON HIS WAY HOME FROM WORK

Our client, who works third shift, was on his way home after work when a county snow plow ran a stop sign causing our client to run into him. Our client's van was totaled due to the accident. He was taken by EMS to a local hospital and was then seen by his family doctor. Our client sustained severe injuries to his lower back and neck.

T-BONED & IN THE HOSPITAL FOR OVER A MONTH

Our client was traveling on Lincoln Avenue when the defendant ran a red light on North Detroit. She was struck and knocked unconscious due to the impact. She was taken by EMS to Toledo Hospital where she stayed for five days. She was then transferred to Flower hospital where she stayed for another month. Our client sustained a broken neck, cracked vertebrae and memory loss. She was then kept on a feeding tube for seven months. Our client is still seeking treatment for her injuries.
