Attorney Charles Boyk interviewed by WTOL out of Toledo

The Clyde Cancer Cluster has been prevalent in the news the past few years. If you are living in northwest Ohio, you most likely have seen a story about it on TV or read about it in the paper. Our very own Attorney Charles Boyk is now working alongside Alan Mortensen, an attorney based out of Utah, to seek answers and hold those at fault responsible for the nearly 40 children who have developed cancer, the many adults that have become cancer stricken and the developmental disabilities in some children.

On Tuesday May 14, 2013 a lawsuit was filed in federal court in Toledo, Ohio naming 27 individual plaintiffs against Whirlpool. Our suit seeks to certify three separate classes of plaintiffs: those who have lost children to cancer, those who have gotten sick either from Whirlpool Plant or Whirlpool Park, and those whose property has been stigmatized causing a significant loss in property value in the town of Clyde. On Wednesday May 15, 2013 a press conference was held at our office where many reporters showed up to ask questions regarding the case. Many of the plaintiffs in the case came as well to speak about their personal story and experience. Also during this press conference, the attorneys released very crucial results to testing that was done in the attics of many of the victims.

The dust samples that were taken from the attics by an environmental expert and analyzed show that in each attic there was an elevated level of Benzaldehyde, which is a hazardous substance and a suspected carcinogen. The levels of Benzaldehyde were the same in homes both old and new, leading to the idea that it got there by the negligence of Whirlpool's operations. The attorneys and the families have invited Whirlpool to conduct their own testing to verify the results.

HOMEMADE FRUIT ROLL-UPS

INGREDIENTS:

- 2/3 cup fruit preserves (you can use whatever flavor and style you like, although jelly is the easiest to work with because it's smooth)
- 2 tsp corn starch

INSTRUCTIONS:

1. Preheat oven to 225°.
2. In a small bowl, combine fruit preserves and corn starch.
3. Cut parchment paper into strips, squares, or whatever shape suits your fancy. Spray lightly with cooking spray, then spread evenly with the preserves mixture. (You can make them whatever thickness you like; some prefer them a bit on the thicker side.)
4. Bake for 45 minutes.
5. Cool completely before rolling them up.

RECIPE

GLUTEN-FREE BREAKFAST COOKIES

Prep time: 5 minutes

Cook time: 20 minutes

Total time: 25 minutes

Serves: 30-35 cookies

INGREDIENTS:

- 1 ½ cup rolled gluten-free oats (I used Bob's Red Mill)
- 2 ripe bananas, mashed
- 1 cup unsweetened applesauce
- ½ cup raisins or cranberries (or a mix of both if that's how you roll)
- ¼ cup chopped walnuts
- 1 tsp vanilla extract
- 1 tsp cinnamon (or more, if that's how you like it)

INSTRUCTIONS:

- Mix vanilla extract and cinnamon in the applesauce.
- Add all ingredients together and let sit for 10 minutes.
- Line a cookie sheet with parchment paper. Drop spoonfuls of cookie mixture onto parchment paper. Flatten into rounds.
- Bake 20-25 minutes or until golden and done.
- Remove from oven, let sit on baking sheet for 5 minutes, then move to cooling rack.
- Store in an airtight container.



DANGEROUS DRUGS: IS YOUR HEALTH AT RISK?

Discovering Which Pharmaceutical Medications & Medical Implants Are Dangerous For Your Health

Pharmaceutical companies are meant to provide medication to help patients with their health conditions, but unfortunately sometimes these medications are the cause of patient harm instead of patient help. There have been several instances where pharmaceutical companies knowingly offer their patients medications that can cause serious side effects.

Errors with medications may occur for many reasons. One of these reasons may be the simple fact that the medication was brought to the market too soon, and did not receive as much testing as it should have. Drug testing is very important, and if the testing period is not long enough, it may not allow the company to find any errors that exist within the medication. When the patient is the one who pays in the form of injury and sometimes death, while a company profits, there should be legal consequences.

At this time, there are several medications with thousands of lawsuits against them. The cause of this may be a lack of proper testing, or it could be the fact that the company was more concerned with profit than patient safety. Some of the medications you may have read about in the news are as follows:

- GranuFlo
- SSRI antidepressants (Paxil, Zoloft)
- Praxada
- Fosamax

Another issue that currently exists within the medical community is faulty medical equipment that many patients have had implanted. Devices that are meant to help improve the lives of patients have in turn caused serious health conditions, and some have even resulted in disability issues. Many patients with the below implants now suffer from lifelong conditions and unknowingly put their health at serious risk:

- Transvaginal Mesh Implants
- Mirena Intrauterine Device
- Metal-on-Metal Hip Replacements (Depuy, Stryker)





CASES OF INTEREST: JUNE 2013

Elementary Student Ran Over By Ice Cream Truck

Our client, a young elementary student, rode her bike up to an ice cream truck. She was hoping to buy ice cream, but instead was run over by the ice cream truck driver. The driver swore at her and drove off. He was later found and charged with leaving the scene of an accident and improper backing. The young girl was transported to Wood County Hospital and his following up with an orthopedic surgeon for a possible fracture.

Woman Ejected From Vehicle & Nearly Dies

Our client was the passenger in her friend's vehicle, when he lost control of his vehicle. She was ejected from the vehicle and nearly died from her injuries. Following the accident, she was life flighted to St. Rita's Hospital with a lacerated spleen, rib, cervical spine, lumbar and pelvic fractures. Since the accident, she has undergone numerous surgeries and will likely need more in the future. This accident happened in March 2013 and this young lady is still in a nursing home trying to recover. Both of the rear seat passengers suffered fractures and they are also recovering.

Distracted Driver Striking Our Client On I-75 Southbound

Our client was involved in a terrible automobile accident on I-75 Southbound. He was stopped for traffic construction and another driver, who was not paying attention, failed to slow down striking two cars. The force of the collision was so horrific, our client's vehicle was less than a foot high following the accident. The jaws of life were used and he was rushed to Toledo Hospital. He sustained a fractured pelvis, numerous rib fractures and a traumatic brain bleed. Following his discharge from the hospital, he was placed in a nearby nursing home where he is still recovering. The other driver is being charged with vehicle assault and DUI.
