
"On Pinewood Avenue a midwife brought me into the world in the front room of my grandmother's house," William said. "It was 1930. Back then people all lived together. My mom and dad and I lived with my grandmother, and I was an only child. I was my grandma's 'baby'; I was so spoiled. She'd always say, 'That's my child!' and I would go with her everywhere she went."

William remembers when milk was delivered to doorsteps by a man on a horse and when long walks to school in the blowing snow simply meant having to walk backward to keep the wind and weather off of your face.

When he was a boy, the fun thing to do on a Saturday was to go down to the Toledo Art Museum with the other neighborhood kids and take free art classes all day in the basement.

William left his life as a Scott High School track athlete to serve as an Army Paratrooper at the age of 15, before the service discharged him when they discovered just how young he was. His family moved to Las Vegas shortly thereafter, and after graduating from Pasadena City College, William enlisted in the Navy, where he served for 12 years.

"I've seen everything," William recalled. "I've been to Tripoli, Nice, Athens, Naples, North Africa – you name it. We would be out at sea all week and be in a different country each weekend."

After the Navy, Amtrak sent him to study at the Culinary Institute of America in Poughkeepsie, New York.

"Spending 30 years on the railroad took me to every major city in the United States," William said. "I met all types of people from all walks of life on those trains."

Despite all of the excitement of life abroad, William chose to settle in Toledo.

"This city's got a lot of history," he said. "It means a lot to me."

# CLYDE CANCER CLUSTER UPDATE: FAMILIES WON THE BATTLE, NOW ALLOWED TO GO TO WAR

The Honorable James G. Carr allowed the Clyde Cancer Cluster case to move forward on February 10, 2014, by denying Whirlpool's motion to dismiss the plaintiffs' complaint in the Clyde Cancer Cluster lawsuit.

Whirlpool had tried to get the Court to dismiss the cancer victims' claims for negligence, wrongful death and loss of consortium, and prevent them from proving punitive damages. In other words, Whirlpool asked the Judge to drop the lawsuit altogether.

The Court denied this request, entitling the Clyde Cancer Cluster victims to begin the discovery process of the litigation.

"This is a huge decision that will for the first time require Whirlpool to reveal the information that they have been reluctant to disclose," Chuck Boyk said. "It is one small step in the search for the truth, and we look forward to examining the information that Whirlpool will have to release."

The discovery process will involve Whirlpool having to reveal an array of records, in addition to allowing the deposition of their employees.

"The most important part of the decision not to dismiss is the fact that it provides the Clyde Cancer Cluster victims and their families the opportunity to properly fight the long battle they have been waiting to fight," Attorney Alan Mortensen said.

## RECIPE:

# Uncle Stu's Sensational Spaghetti Sauce

*Who knew that not using the jarred stuff could be so easy (and delicious!)? This sauce works well over pasta or on pizza and can even be made in the crock pot.*

### INGREDIENTS:

- 1 medium sweet onion
- 1 (8 oz) package portabella mushrooms
- 2-3 cloves of garlic, chopped
- 2 Tablespoons olive oil
- 3 cans diced tomatoes (28oz each)
- 1 (6 oz) can of tomato paste
- 2 Tablespoons Italian seasoning
- 1 teaspoon salt
- 2 Tablespoons brown sugar
- 1 cup red wine
- ½ teaspoon crushed red pepper

### INSTRUCTIONS:

1. In large pot, over medium heat, sauté mushrooms, onions and garlic in olive oil until soft.
2. Add remaining ingredients, adding more wine (or water) as necessary for desired consistency.

3. Over medium/high heat, bring to a boil. Boil two minutes, stirring frequently.

4. Reduce heat to low, cover and stir occasionally for at least 20 minutes.

\*\*If making in a crock pot, stop after Step 2. Instead of boiling, add all ingredients to the crock pot and cook for 5-6 hours on low.


Jeff Wilbarger, the Project's founder, was humbled that so many people would reach out to help the anonymous women who live at the Daughter Project House.

## Police Car Strikes Man Walking On Bridge, Causing Him To Fall 50 Feet To Frozen Swan Creek

A Lucas County sheriff lost control of his patrol car, striking our client with such force that he was thrown from the bridge on which he was walking. The combination of the car hitting his body and his body striking the solid ice below caused our client to suffer multiple life-threatening injuries, including a traumatic brain injury, brain bleed, fractured back and pelvis, collapsed lungs and ruptured spleen, among other injuries that are being discovered daily. Our client was put into a medically-induced coma, remains in the ICU and is facing months in the hospital.

## Passenger Suffers Multiple Injuries After Car Strikes Utility Pole

Our client spent two days at St. Vincent's Medical Center after being transported by EMS to treat injuries caused after the car she was riding in hit a utility pole head-on. Her head struck the side window with such force that the glass cracked, causing her to suffer a severe concussion that has left her with lingering dizziness and migraines. She is also suffering from serious back and ankle pain as a result of the wreck.

## Car Accident Leaves Young Woman Unconscious, Unable To Attend College

A position with a new company and classes at a local college were put on hold after our client suffered a traumatic brain injury from a car accident. A passenger in the car, our client was knocked unconscious and sustained injuries to her neck, back and shoulders, in addition to a hip sprain, cervical sprain and concussion.
