RECIPE

RUTHANN'S PUMPKIN CRUNCH

"This is a great recipe that my family really likes!" – Ruthann Henninger

Prep: 5 Minutes

Total Time: 29 Minutes

Makes: 4 Servings

INGREDIENTS:

- Whipped topping
- 1 box yellow cake mix
- 15 oz can pumpkin
- 12 oz can evaporated milk
- 3 large eggs
- 1 ½ cup sugar
- 1 tsp cinnamon
- ½ tsp salt
- ½ cup chopped pecans
- 1 cup butter

DIRECTIONS:

Preheat oven to 350 degrees, apply non-stick spray to the bottom and sides of 9x13 casserole dish. Mix pumpkin, evaporated milk, eggs, sugar, cinnamon, salt and then dump into pan. Sprinkle cake mix over mixture evenly. Top with pecans and drizzle melted butter over pecans. Bake at 350 degrees for 50-55 minutes let the desert cool and serve with whipped topping.



CASES OF INTEREST: NOVEMBER 2012

VACATION MOTORCYCLE ACCIDENT

Our client was a passenger on a motorcycle while she was vacationing in Michigan. As they were traveling on the highway the trailer in front of them began to experience problems. As she and the driver of the motorcycle went to pull over to help the trailer, they were hit from behind by another motorist who became distracted while looking at the disabled vehicle. Our client suffered a fractured wrist, a broken ankle, multiple facial contusions and multiple lacerations.

FEMUR BROKEN AT WELL-KNOWN THEATER

Our client was walking to the restroom at the Stranahan Theater when she was knocked down and another patron of the theater fell on top of her. She was taken from the scene to St. Luke's and was diagnosed with a broken femur. She was then admitted to a local nursing home facility for physical therapy, where she had to stay for approximately a month.

WOMAN SERIOUSLY INJURED IN HIT & RUN ACCIDENT

Our client was on her way to work when she was t-boned by another motorist who failed to yield at a traffic sign. The driver of the other vehicle fled the scene, while our client had to be cut out of her vehicle and transported by ambulance to the Toledo Hospital. Our client sustained injuries to her left leg and knee as well as neck injuries and bruises to the abdomen, right arm and upper back. As a result of her injuries, an abscess also formed on her left leg. Several weeks following the accident, her leg developed cellulitis and she was admitted back into the hospital. She is currently receiving home nursing care for the acute infection.
