Top Tips for Pedestrian Safety

rowing up, we're all told to look both ways before we cross the street. However, pedestrian safety relies on more than just that - it requires both walkers and drivers to be attentive and careful.

Although the number of pedestrian fatalities has fallen in recent years, there were still 69,000 reported pedestrian injures in 2008, according to the National Highway Traffic Safety Administration. Nearly half of these accidents occurred



Sunday, with the vast majority happening at night. Here are some tips to make walking more safe for both drivers and pedestrians: The Driver Do:

- Slow down when around pedestrians
- Yield to pedestrians at

all crosswalks

- Look for eye contact from pedestrians waiting to cross the street
- Watch for pedestrians before making a turn
- Apply the brakes early when stopping in bad weather
- Be especially cautious around schools or where children are likely to be Don't:
- Pass when the car in front of you has stopped at a crosswalk
- Stop your car in the middle of a crosswalk

Karen's Freezer Caramel Drizzle Pie Ingredients

2 (9 inch) prepared graham cracker crusts

6 tablespoons butter

1 (7 oz) package shredded coconut 1 cup chopped pecans

1 (14 oz) can sweetened condensed milk

1 (8 oz) package cream cheese, softened

1 (16 oz) container frozen whipped topping, thawed

1 (12 oz) jar caramel ice cream topping

Directions

1. Place butter in a medium skillet and melt over medium heat. Add coconut and pecans, stirring to coat. Sauté until coconut and pecans are lightly toasted, about 5 minutes. Set aside.

2. In a large mixing bowl, whip together condensed milk and cream cheese until fluffy. Fold in whipped topping. Spoon 1/4 of cream cheese mixture into each graham cracker crust. Drizzle each with 1/4 of caramel topping. Repeat layers with remaining cream cheese mixture and caramel. Top each pie with coconut and pecan mixture. Freeze overnight. *Makes 2 pies.*

24-year-old passenger in vehicle is knocked unconscious and spends six days in the hospital after the vehicle rolls. She was Life-Flighted to St. Vincent's and is being treated for a closed head injury and injuries to her right thumb, left foot, right knee, and jaw.

33-year-old man on motorcycle injured after a car crosses five lanes of traffic and strikes victim's bike. The victim was taken via ambulance to Toledo Hospital where his wounds were scrubbed and he was treated with antibiotics. The victim suffered road rash and scarring to his hands, forearms and left knee.

19-year-old bicyclist is struck by vehicle while riding in the gravel on the side of the road. The victim was thrown 30 feet and knocked unconscious. She now suffers from a traumatic brain injury, two fractured hips and a tom MCL and ACL in the left knee, which requires surgery to repair.

55-year-old man in motorized wheelchair is struck by a car while crossing the street. He was taken to the emergency room and admitted. He suffered a broken jaw and his ear was tom apart; he had surgery the day after his accident to treat his injuries.
