## Hidden policy language can put families at risk

ear Dale: I recently caused a car accident in Toledo in which my children were hurt. When I contacted my insurance company about my children's injuries. I was told that they would not be covered under the terms of my policy because they are part of my family. When I signed up for my insurance, I asked for full coverage and I was told that's what I was getting. Can my insurance company do this?

Answer: Not only can your insurance company do this to you, it happens all the time. That doesn't make it right, but the law allows this difficult-to-justify



practice.

At our personal injury office, we see similar situations fairly often. It's tough to tell someone that their insurance company won't cover them for injuries to a family member if they caused the accident because of an intra-family exclusion in the uninsured motorist coverage portion of the pol-

icy. These exclusions typically state that an uninsured vehicle does not mean a vehicle owned by you or any resident of your household.

Insurance companies need to follow a laundry list of state laws when it comes to the language of their policies. But for years, many Ohio legislators seemed willing to dance to whatever beat the insurance-company lobbyists were pounding out. I've never understand why those legislators wouldn't stop and say, "Hey, my family could be financially devastated by this vote." This should be a common sense,

quence as well.

Isn't this why we buy insurance – to protect not only other drivers, but ourselves and our loved ones? Does it make any difference to the real-life Billy and Bettys that the accident was caused by their dad and not some other negligent driver who wasn't insured? Aren't their injuries and losses the same regardless of who caused the accident?

As near as I can tell, insurance companies who have intra-family exclusions justify them in a few ways. One is to help prevent fraud by family members who claim bogus injuries from accidents, staged or real. I'm sure insurance companies also would say that people can bargain for the coverage they want and it holds down premium costs for all of us to not require this coverage automatically.

While I know some claimants are dishonest, most insurance adjusters are smart people who are good at sniffing out bogus claims. And as far as the costs go, I can't imagine premiums would increase in any significant way once the risk to the insurance company is spread out among all drivers. In my opinion, this is about insurance com-

panies stuffing more money in their pockets.

Not all insurance companies write intra-family exclusions as a matter of course. If

you're concerned about this, and you should be, ask your insurance agent to find you a policy that doesn't contain this exclusion. Most agents, especially independent ones, will be more than willing to help you find a policy that protects you and your family.

And if you want to change the law that allows these types of exclusions, write or call your state legislator and the leaders of the General Assembly. It just might make a difference.

Let me give you a fictional example of how a family could be crushed financially as a result of these types of policies. Let's say Bob is driving his wife, Jane, and two kids, Billy and Betty, to the zoo. Bob takes his eyes off the road for a second, runs a red light, and is hit broadside by a truck. The accident causes brain injuries to Jane, who is the breadwinner for the family, and Billy and Betty have serious internal injuries that require weeks of hospitalization.

Bob lost his job recently and doesn't have health insurance, so the hospital bills quickly swamp him. Not only that, but the family has lost Jane's income. Bob thinks he has full coverage. so the kids will have their medical bills covered and get some money for injuries that likely will cause years of pain and expense, and Jane will be compensated for her injuries and loss of income. But intra-family exclusion language related to the uninsured motorist coverage portion of his policy means Jane, Billy, and Betty will get nothing, and this family catastrophe now has a devastating financial conse-

# Cases of Interest our office is handling

**50-year-old woman is rear-ended by a drunk driver,** causing severe neck and back injuries.

44-year-old man is still hospitalized after nine weeks after being struck by a car while trying to help an accident victim on the side of the road. He will need multiple surgeries to fix his dislocated knees.

**56-year-old man falls inside a local gas station** due to inadequate warning of hazardous conditions. The fall caused a severe compound wrist fracture and need for surgery.

45-year-old woman uses a defective facial product and develops a staph infection, requiring a week-long hospital stay and permanent facial injuries.

**17-year-old passenger is knocked unconscious** after the car he is riding in strikes a tree. He suffered a concussion and injuries to his back.
