



Final Bikes For Kids Winner Graduates From Program That Teaches Kids With Disabilities How To Ride Bicycles

Riley Draps was recognized for all of the work he did learning how to ride on two wheels despite his limitations from Autism.

"Riley is always smiling and carefree," Peggy Krueger, Riley's step-grandmother, wrote in her nomination. "He has worked hard to participate in Gliding Stars, he likes to swim, do karate, and with the help of PEAC, we are trying to get him into biking."

He received his bicycle the day before his three-mile bike ride at the PEAC graduation at Swan Creek Metropark. Programs to Educate All Cyclists, or PEAC, is a non-profit organization based in Ypsilanti, Michigan whose mission is to empower individuals with disabilities through cycling, active transportation, and self-advocacy education. Riley participated in PEAC's seven-week Summer Cycling program that teaches individuals of all abilities how to cycle. Toledo was one of seven locations serviced by PEAC.

Stephanie Morrill, Riley's instructor, enjoyed spending the summer teaching him to ride.

"Riley was great to work with," Stephanie said. "There were times where we had to adjust how we worked with the bike but he always was willing to try. He was so proud of himself when he learned to ride a two wheeler on his own and he has a very supportive family and they were even willing to work with him after the program was done for the season to continue his progress for when we work with him again next summer. He's a boy that brings a smile to your heart

Bikes for Kids was excited to be a part of such a great milestone in Riley's life.

"We hope this bike provides years of riding for Riley and encourages others to help those with disabilities learn how to ride," said Chuck Boyk, founder of Bikes for Kids. "We applaud PEAC for taking the time to empower riders of all abilities."

In-depth Investigation by Boyk Law Helps Woman After Car Accident Lands Her in ICU

A 19-year-old driver claimed he did not run a red light after striking our 79-year-old client in an intersection, causing injuries that required her to be hospitalized in ICU for a week and on life support with a brain bleed, liver laceration, and collapsed lung. Our client also suffered a broken ankle and toe and will continue to receive treatment at an in-patient rehabilitation nursing home for the foreseeable future. We have represented the family in the past and they reached out to us for help after the insurance company denied liability and refused to pay medical bills after the accident. Boyk Law took over the investigation and obtained surveillance video of the footage proving that the at-fault did not have a green light like he claimed. Instead, video showed that the light was red for a full nine seconds while he raced through the intersection.

Stack of Pallets Falls On Worker, Causing Need For Multiple Surgeries

Our client is still unable to work four months after a work accident caused him to suffer an open fracture of the tibia and fibula, internal bleeding, and the need for major surgeries. He had to have implanted a drain tube for the bleeding as well as a rod, screws, and bolts into his leg after a stack of pallets that was stacked too high fell over onto him. Five days after the initial surgery, an additional operation was needed to remove the drain and clean the suture, and our client is still undergoing physical therapy to relearn how to walk without assistance.

McDonald's Employee's Mistake Causes Customer To Need Surgery

Our client slipped and fell on a wet floor inside a local McDonald's, causing multiple fractures to her right ankle. The employee apologized profusely while stating that they forgot to put out a "wet floor" sign after mopping in the public area. Our client was rushed to the emergency room, was hospitalized for three days, underwent surgery to implant a plate and four screws, and faces months of recovery as she is still non-weight bearing so unable to start physical therapy.
