Bev's Shrimp Francesca

Ingredients

1 pound uncooked large shrimp, peeled and deveined

- 1 (8 ounce) can (8 to 10 count) artichoke hearts in water, drained
- 1/2 cup Italian seasoned bread crumbs
- 1 tablespoon chopped fresh parsley
- 1 lemon, juiced
- 1/2 cup butter
- 1 1/2 tablespoons minced garlic
- 1 tablespoon finely shredded imported Romano cheese

Directions

- •Preheat oven to 375 degrees. Lightly grease a 9x13-inch baking dish.
- •Arrange the shrimp in the bottom of the prepared baking dish. Gently squeeze any excess liquid from the artichoke hearts, break the hearts into quarters, and arrange in spaces between the shrimp. Sprinkle the bread crumbs and parsley over the shrimp and artichoke hearts; sprinkle lemon juice over the crumbs.
- •Melt butter with garlic in a small saucepan over medium-low heat; drizzle the butter mixture over the bread crumbs. Sprinkle the top with Romano cheese.
- •Bake in the preheated oven until the crumbs and cheese brown lightly and the shrimp turn opaque and orange-pink in color (10 to 12 minutes). Serve hot over buttered angel hair pasta. Serves four.

Safe Driving Tips of the Month

- Before driving, do a simple safety check: make sure all lights and blinkers are in working order, check fluid levels and check tire pressure.
- Adjust your mirrors and seats before putting the key in the ignition.
- ALWAYS wear a seatbelt.

- In inclement weather, apply your brakes slowly and without any sudden moves. Making sudden moves increases the chances of you losing control of your vehicle.
- Remember that as your speed increases, so does your braking distance. If you double your speed, you quadruple your braking distance.

41-year-old woman is rescued from her vehicle by the Jaws of Life after being hit by a car running a stop sign. She suffers a ruptured spleen, which has to be surgically removed, and lacerations to her kidney, liver and lower intestine. A multiple foot fracture and an open tibia/fibula fracture were also surgically repaired. Extensive rehabilitation is necessary.

33-year-old man riding his motorcycle is injured when a car driven by an uninsured motorist turns in front of him and causes a crash. The man was Life Flighted to UTMC with multiple fractures, including to his pelvis and right ulna. He underwent two surgeries. He is still treating in rehab and may be there for two months. He has had to seek reduced-cost care as there is not enough insurance coverage for his claim.

66-year-old woman with dementia has to have finger amputated after being neglected in her nursing home. Approximately one month after entering the nursing home, the woman's daughter noticed her mother's finger was badly swollen. The woman was taken to UTMC where her finger had to be amputated. The nursing home denies there was any incident.
