student currently attending an accredited college or university who either is a veteran or is the child of a veteran. On the heels of Veterans' Day, Boyk Law is happy to announce this year's winner: Alex Box.

Alex is a proud native of the Toledo, Ohio area, raised along with his younger brother by a single father in a low-income home. Alex's dad always impressed upon his boys a deep respect for hard work, coupled with a drive to always want the most from life. Alex attended Sylvania Northview High School, where he was a varsity wrestler and football player. After graduating from Northview in 2007, Alex accepted a 4-year Army ROTC scholarship and graduated from the University of Dayton in 2011.

As a senior in college, Alex knew he wanted to take the LSAT and go to law school. However, he knew the U.S Army had given him the opportunity to attend college in the first place, and

he honored his commitment to the armed forces by postponing law school and giving everything he had to the Army. As his peers studied for the LSAT, Alex trained for U.S. Army Ranger School. He became an Airborne Ranger and boarded a flight to Eastern Afghanistan with the 101st Airborne Division, the first of two combat deployments. In Afghanistan, Alex served as a Reconnaissance Platoon Leader. He eventually earned the rank of Captain and concluded his seven-year Army career in 2018 after a deployment to Kuwait.

The U.S. Military made Alex who he is today. It taught him that even someone who perceives himself as "average" can achieve extraordinary things if he is willing to go to extraordinary lengths to achieve his goals. By embracing and harnessing a mentality that nobody would out-will him, out-want him, or outwork him, he excelled in the U.S. Army and in his service to the country. During his military career, Alex earned a Ranger Tab, Airborne Badge, Air Assault Badge, Pathfinder Badge, and Combat Action Badge.

While in the Army, Alex earned a Master's Degree in Organizational Leadership. He was always adamant that one day he would return to his ultimate goal of attending and graduating from law school. Now, Alex is well on his way to achieving his goals. He started at Loyola University Chicago School of Law this fall, pursuing dual J.D./M.B.A degrees.

Upon learning he had been awarded the scholarship from Boyk Law, Alex said: "I find myself unbelievably appreciative of the opportunity to receive the Boyk Law Veteran

## RECIPE: Grandma Sally's Candy Cane Cookies

#### **INGREDIENTS**

- 1 cup Oleo Oil
- 1 cup Powdered Sugar
- 1 Egg
- 2 ½ cups Flour
- 1 tsp. Salt
- 1 ½ tsp Almond Flavoring
- 1 tsp. Vanilla Flavoring
- Red food coloring

#### **DIRECTIONS**

Mix well the oleo, sugar, eggs, almond flavoring and vanilla flavoring. Stir in flour and salt. Divide dough in half, and blend the red food coloring in one half. Roll 1 tsp. of each color until it is about 3 inches long. Twist the two colors together, and shape like a candy cane. Bake at 375 degrees for 10-15 minutes.

### Nursing Home Neglect Leads to Fall Injury

Our firm is representing the family of an elderly woman who suffers from dementia. Earlier this year she sadly lost her husband, who provided care for her. Given her need for around the clock care, the family made the difficult, but necessary decision to move their mother to an assisted nursing facility. The facility was made aware by the family and medical providers that she was a fall risk and assured the family they were trained and equipped to provide such care. Despite their promises, shortly after placing their mother in the facility's care, she fell and broke her femur and hip – requiring extensive surgery and a painful and uncertain rehab.

#### Father of 3 Killed in Tragic Turnpike Trucking Accident

Our firm is representing the family of a young man who was killed on the Ohio Turnpike in Sandusky County. The Wilmington, Delaware man was traveling westbound on the turnpike where witness reports indicate he may have experienced car trouble and pulled his vehicle off the side of the road. Another traveler also pulled off behind him to provide assistance. Despite being off the road with hazard lights on, a truck driver plowed into the vehicles, killing the man.

### 2 Killed, 4 Injured in Deadly Allen County Crash

Our client was on his way to visit a family member at St. Rita's Hospital, but ended up at the hospital as a patient, not a visitor. In route, a vehicle pulled out into an intersection in front of our client. The 20 year old driver of that vehicle had four teenage passengers with him. One of passengers died at the scene and one at the hospital. All others, including our client, were transported to St. Rita's with serious injuries. Distracted driving is suspected to be a factor in the accident.
