

### Mourning and Celebrating One of Toledo's Great Attorneys: Timothy C. James, 1954-2019 – by Katie R. Harris



As lawyers, we have a job that is adversarial by nature. It can be quite contentious, and lawyers do not always "play nicely" with each other. Luckily, sometimes we come across the rare person who is a joy to know

and work with even though that person's job is fighting against us on cases. Tim James, a 30-year partner of the Toledo insurance defense firm Ritter, Robinson, McCready & James, Ltd., was one of those rare people. With his recent passing, we are mourning the loss of a brilliant legal mind, an honest and compassionate adversary, and a friend.

Tim was one of Chuck's frequent and favorite adversaries, and Chuck will miss him greatly. "This is very, very sad," Chuck said on learning that Tim had passed away, "Tim was a fantastic attorney and better person. It was always fun to talk to him and be around him. He was like a big kid. I loved getting cases with him because it meant I got to spend time with him, and I always knew he was going to be fair." Attorney Mike Bruno remembers Tim as "one of the good ones for sure" and always enjoyed his company, while Attorney Leah Michael adds, "We lost a great man. He was a magnificent person. It's truly heartbreaking."

I knew Tim James in a different way than the other members of our team did because I worked for him before I joined Boyk Law about a year ago. Although I changed jobs to represent plaintiffs, I am immensely grateful to have worked with and learned from Tim, and I could not have picked a better mentor for my early years of private practice. He taught me how to be a good lawyer while also being a good person, and that it was possible to be a fierce and successful litigator while staying humble and maintaining a sense of both humor and compassion.

I'll never forget the mischievous look on Tim's face in June 2017 when he asked me, "How busy are you?" before delivering several huge boxes of papers to my office floor and asking me to help him learn a new-to-us case that was going to trial in August. I will also never forget him popping in my office doorway those summer evenings to happily announce that he was going home "to ride bikes with Marianne", his wife of almost forty years. He would remind me not to stay too late on those beautiful days, and I knew he meant it because being with family was a priority for him and he valued it for his associates as well. He knew we could learn the case backwards and forwards and win at

trial without sacrificing our most important relationships. Those months were some of the busiest of my life, but I wouldn't trade them for anything because working almost exclusively on that case meant I spent almost all day every day working closely with Tim, and nothing could have been better.

I have never met anyone who didn't like and respect Tim James, even among those who were his most aggressive opponents. That is exceedingly rare among regular people and even rarer among lawyers, but that was just Tim. He lived his life and practiced law with humor and friendship, and he has been universally loved for it.

The Northwest Ohio legal community and the world are sadder places without Tim here, but so much richer overall because of the time he gave us. I miss him tremendously, but more than anything I feel proud and lucky to have known him. Working with him, knowing him, and laughing with him changed me for the better, and I will strive to spend my entire career practicing law in a way that would make Tim proud.

If we all practiced law and lived life like Tim James, the world would be a better place.

## Hockey Player & His Family Seek Justice After Coach's Actions Caused A Serious Fracture & Kidney Injury



When parents watch their children play sports, they leave a lot to trust. They trust that the coaches for every team will be well-trained, that player safety will be a top priority even for opposing team coaches, and that the coaches will not allow preoccupation with the score to interfere with their responsibilities to the children under their care. Unfortunately for the Bisson family, their trust was betrayed when the Sylvania North Stars played the Plymouth Stingrays at the Huntington Center last February.

Hockey is part of who the Bisson family is, including 14-year-old Josh. Born in Canada,

Josh has been playing hockey since he was 3. By the time he was 13, he was a skilled player for the AAA Sylvania North Stars. Based on Josh's talents, he and his parents had every reason to anticipate that he would earn a place on a Detroit or Maryland AAA travel team after the 2017-2018 hockey season, setting the stage for even more success in the future. That dream ended during an exhibition game between the North Stars and the Plymouth Stingrays.

The game started out very well. Sylvania went up to a 4-0 lead in first period and led the Stingrays 6-2 in the third period. As the North Stars built and maintained their impressive lead, the game became increasingly chippy, and a coach on Plymouth's bench door could be heard yelling at players from all the way across the arena. With less than two minutes to play in the game, Josh saw an opportunity. He broke away with the puck, skating fast along the boards toward Plymouth's goal. A Plymouth player was in hot pursuit, skating in fast to put a solid hit on Josh to prevent yet another North Stars goal. As the Stingrays player pursued Josh, it was obvious he would check Josh in front of or immediately near the Stingrays' bench door. No other players were near them on the ice, and nothing indicated a line change was about to occur for either team.

Right before the inevitable hard hit on Josh, the Plymouth assistant coach cracked the Stingrays' bench door and then opened the door wide for no reason, exposing the edges and corners of the wall.

Then the hit came, slamming Josh directly into the exposed danger. He was thrown backwards and fell hard, unable to finish the game. It was clear even at the Huntington Center that Josh's collar bone was broken, but an even scarier situation developed later that afternoon as Josh continued to vomit and complain of stomach pain. Within half an hour of returning home from urgent care, the Bissons rushed Josh back to the emergency room because he had started urinating dark blood. Tests at the ER revealed that Josh had a grade four kidney laceration – the worst level a kidney laceration can be before the kidney is considered shattered.

The Bissons came to Boyk Law last summer and we recently filed suit in federal court in Toledo. Based on the evidence, the Plymouth coach opened the bench door in front of an active play for no reason whatsoever when he should have known better. Opening that door in front of an imminent hit exposed Josh to extraordinary risks well beyond what you would expect in hockey, and it never should have happened. Far from making player safety a top priority, the Plymouth coach showed absolutely no care for the players on the ice, and Josh was badly hurt because of it.

Boyk Law hopes to secure justice for Josh and his family, and to send a message to all youth sports organizations that they should take stock of what really matters – the safety of players entrusted to their care – so that fewer players in the future will be injured by reckless, wanton acts that never should have happened.

## RECIPE: Brazilian Requeijao Cremoso

### **INGREDIENTS**

- 4 cups milk
- 1 cup corn starch
- 2 cups grated good quality Parmesan cheese
- 2 1/2 cups shredded mozzarella cheese
- 3 tablespoons butter, unsalted
- 1 1/2 to 2 cups of heavy cream
- Salt to taste

#### DIRECTIONS

Start by dissolving the corn starch in the milk.

In a medium pot, combine the milk/corn starch mixture, the butter, the mozzarella and the parmesan. Bring to a boil, over medium high heat, stirring constantly, until the cheese melts and the mixture thickens, about 5 minutes.

Transfer to the blender and add one cup of heavy cream. Blend until smooth, adding more heavy cream as necessary for a consistency similar to sweet sweetened condensed milk. Taste for seasoning and add salt if necessary.

Use immediately or refrigerate for up to a week.



### Recall of Blood Pressure Medications Expanded Over Carcinogen Concerns



Since July 2018, multiple pharmaceutical companies have recalled blood pressure medication containing **valsartan and losartan**. In January 2019, that recall was expanded yet again. The recalls stem from concerns that the products may be contaminated with **N-Nitrosodiethylamine (NDEA) and N-Nitrosodimethylamine (NDMA)**. The FDA has announced that NDEA and NDMA are classified as probable human carcinogens as per the International Agency for Research on Cancer.

Patients taking medications containing valsartan or losartan should contact their pharmacist or physician who can advise them whether their medication is affected by the recall and if so, what alternative medications may be available.
