# **Don't Quit Your Medical Treatment**

Getting hurt is no picnic. You may have spent hours waiting in the ER, and had to juggle doctor and therapy visits on an already busy schedule. And many times a full recovery is months or maybe years away.

after the 3rd week, telling his therapist he with recommended medical care should had a pain level of 5 on a 10-point scale. Sheila on the other hand, completes all of her therapy visits with pain at 1 out of 10. Because of that, she will be able to claim pain and suffering for the full 6 weeks and perhaps longer.

During Frank's trial, the defense will argue that his failure to follow-through prevent him from seeking pain and suffering damages after his decision to quit therapy.

# **Clinical Trial Underway For Potential New Treatment Option For Patients With Mesothelioma**

Mesothelioma is a rare cancer with about of waste and that the cells must dispose 3,000 new cases in the United States each of or it can become toxic to the tumor year. With limited treatment options, it is nearly always fatal. Mesothelioma is so hard to treat because it typically does not grow as a single tumor, but rather spreads along to other tissue, nerves, and blood vessels. As such, surgery and/or radiation are often ineffective options. Since 2004, only two therapies have been approved for mesothelioma patients.

However, researchers at the University of Vermont Cancer Center and Wake Forest Medical School have identified a new therapeutic approach that is causing considerable optimism. Researchers discovered that tumor cells produce a lot

and kill it. The new drug is designed to inhibit a tumor cell's ability to manage its toxic waste. Researchers noted that it is basically "like putting a potato into the tailpipe. The tumor cells choke on their own exhaust."

While the research has been centered around mesothelioma, there is considerable data to suggest the therapy could work on other cancers as well. Clinical trials are underway throughout the United Kingdom and may move to the U.S. in 2022.

Exposure to asbestos causes almost all mesothelioma cases. Mesothelioma often



develops decades after asbestos exposure occurs because it takes time for asbestos fibers to cause the damage that leads to cancer. 

# **CASES OF INTEREST: DECEMBER 2021**

#### T-bone Accident Ejects Woman from Vehicle

Our client was a passenger in a vehicle traveling southbound in Roxand Township, Michigan. As our client's vehicle entered an intersection, another driver traveling westbound disregarded the stop sign and T-boned the vehicle our client was traveling in. Upon impact our client was thrown from the vehicle and suffered a degloving injury to her hand. She also suffered fractures to her neck, ribs and jaw. She underwent significant skin grafts and spent several days in a hyperbaric chamber. Our client is undergoing extensive treatment and faces a long road to recovery.

#### Drunk Driver Flips Vehicle Causing Extensive Injuries to Passenger

Our client was a passenger in a vehicle traveling on a county road in Sandusky Township, Ohio. The driver had been drinking and was operating the vehicle at a speed of approximately 140 mph. The driver lost control of the vehicle, drove off the roadway, struck a fence, and drove through a ditch causing the vehicle to flip multiple times before striking a utility pole. Our client was life-flighted to Toledo Hospital. He suffered a broken back and underwent a spinal fusion

which required placement of two metal rods. Our office is pursuing a claim against the driver of the vehicle.

#### Mail Carrier Hospitalized for Several Days after a Dog Attack

Our client was working as a postal carrier and was delivering mail in Swanton, Ohio. As he was walking his normal route, a dog which was not on a leash, ran off a home's front porch and attacked the mail carrier's hand and chest. He suffered multiple puncture wounds to his hand and was taken to the hospital by EMS. The wound became infected and our client was kept in the hospital for several days. He is now pursuing a workers' compensation claim and a separate claim against the dog owner.
