

Your Rights: Ohio Slip and Fall Laws

With winter weather settling in, it is inevitable that some will slip and fall. While we hope this never happens, if it does, the attorneys and staff at Charles E. Boyk Law Offices, LLC are here to help.

I Slipped and Fell on Ice or Snow, What Can I do?

Well, it depends. In Ohio, the law recognizes a "Winter Rule" that states the risk of snow and ice are part of winter. Because of this, a business will not be liable for a fall due to snow or ice, because these hazards are well known and individuals should know and look out for these hazards.

However, the law recognizes an exception known as "Unnatural Accumulation." Here, liability may be present if the hazard was created by something other than natural forces. Put differently, if the snow or ice hazard is created by something other than low temperature, wind, or other natural occurrences, a business may be liable.

But there are still limits to this exception, based on the reason why you were where you slipped and fell, discussed below.

What Standard of Care am I Owed?

Ohio recognizes three categories when someone is out and about: invitees, licensees, and trespassers.

To be an invitee, you must be on the premise of another, by invitation, for a reason beneficial to the owner. Invitees are owed the duty that a business exercise ordinary care to

maintain the premises in a reasonable safe condition and to warn invitees of hidden dangers. However, if you are in a business or premise for a reason that extends the scope of the owner's invitation, you will be considered a licensee or trespasser. In the case of being a licensee or trespasser, you are only owed not to be subjected to "wanton or willful" negligence.

This difference really matters.

Imagine you're walking in front of a store, about to enter to purchase items. Before you make it through the door, you slip and fall on a patch of ice covered by the snow. You later discover that the ice formed not because of the snow and cold conditions, but because the store allowed a pipe to leak, which froze and

was hidden by the snow. Here, since you are in invitee, because you are entering the store to shop, you will likely have a case against the store. However, let's say you are walking in front of the same store, but have no intention to enter and shop; you are simply walking in front of the store to get to a different location. Same slip occurs due to the same reason. Here, there is likely not a case because you are considered a licensee, and the leaky pipe is likely not considered wanton or willful.

RECIPE:

Mom's "Most Requested" Cinnamon Cheesecake Squares

INGREDIENTS:

Crust

- 2 (10-ounce) cans refrigerated crescent rolls *Filling*
- 2 (8 ounce) packages softened cream cheese
- 1 cup sugar
- 1 teaspoon vanilla extract

Topping

- 1 stick butter, melted
- ½ cup sugar
- 3 teaspoons cinnamon

INSTRUCTIONS:

- 1. Press 1 package of crescent rolls in the bottom of ungreased 9 x 13 pan. Press and pat the perforations together.
- 2. Mix cream cheese, 1 cup sugar and vanilla. Pour over crescent roll crust and spread to sides.
- 3. Lay the second can of crescent roll dough onto a piece of waxed paper. Pat the perforations together and carefully stretch dough as needed to fit the pan. Flip the waxed paper over placing the dough onto the cream cheese layer and remove the paper.
- 4. Melt the butter and pour over the top crust. Mix the ½ cup sugar and cinnamon together and sprinkle over the buttered dough.
- 5. Bake at 350 degrees for 25-30 minutes until the top is brown and bubbly. Allow to cool until firm and then cut into squares.
- 6. Andrea's mom said this was her most requested recipe ever! Her instructions suggested keeping copies of it on hand for guests whenever you serve them.

Rear-end Accident Leads to Traumatic Brain Injury


Our client was travelling northbound on State Route 235 in Orange Township, Ohio. As our client slowed for traffic, the vehicle behind him failed to slow and smashed into the rear end of his vehicle. The impact forced our client's vehicle into the vehicle ahead of him. Upon impact our client's head hit the steering wheel causing a significant laceration and concussion. Our client was taken by ambulance to the hospital where he was admitted and treated for a concussion and several other injuries. He underwent stitches to his forehead. Due to his traumatic brain injury, he experienced ongoing headaches, memory loss, and issues with competency.

Motorcyclist Dies In Intersection Collision

A father of three was operating a motorcycle on Bayshore Road in Oregon, Ohio.

At the same time a pickup truck was travelling northbound on N. Stadium Road approaching Bayshore Road in Oregon, Ohio. The driver of the pickup truck failed to stop at the stop sign, entering the motorcyclist's path of travel, causing the vehicles to collide. The motorcyclist was ejected from the motorcycle suffering fatal injuries. Our office is pursuing a wrongful death claim on behalf of the family he left behind.
