## **Boyk Law Files Suit Against City of Toledo** For Deadly Police Pursuit Practices

Toledo Police engage in vehicle pursuits at a rate 350% higher than the national average, as per the U.S. Bureau of Justice Statistics. The majority of their high-speed chases often stem from minor traffic violations. The tragic case of Mohamed Souare exemplifies the severe consequences of TPD's pursuit practices and the need for change.

A U.S. citizen and Army National Guard member, Souare was an innocent bystander who fell victim to a pursuit initiated after a minor infraction. Despite knowing the driver's identity, residence, and only a minor offense being involved, a pursuit was initiated by TPD and conducted at speeds over 110 mph through residential neighborhoods. Ultimately, the chase ended with TPD units crashing into each other, and a fatal collision involving Mr. Souare.

Boyk Law filed a civil suit on behalf of Mr. Souare's family in federal court. "Toledo's pursuit practices prioritize suspect apprehension over public safety, deviating from the practices in other major cities and placing innocent citizens in harm's way," said the family's attorney Charles Boyk. "Our suit not only seeks to recover wrongful death damages for Mr. Souare's widow and his two young children but also seeks to help drive needed changes in TPD pursuit policies to protect the public."

The Toledo Police annually conducts close to 28 pursuits per 100 officers - 350% more than the national average. Most of these pursuits are for a minor traffic infraction.

Over 36% of TPD's pursuits result in an accident. These pursuits not only result in injuries to suspects and officers but the vast majority of pursuit injuries are suffered by innocent bystanders who happen to be in the wrong place at the wrong time.

While other cities restrict pursuits unless they involve violent felony offenders who present a greater and immediate danger to human life, TPD's pursuit practices place apprehension of the fleeing suspect, not public safety, as the paramount objective. When injuries occur to innocent citizens, TPD justifies its actions and blames the fleeing driver.

Charles Boyk Law Offices filed suit against the City of Toledo on behalf of Mr. Souare's family. We are hopeful that, in addition to bringing justice to Mr. Souare's family, the City of Toledo is forced to confront and change its practices for the safety of the citizens it is sworn to protect.

## Michigan Governor Signs Law Repealing Immunity for Drug Manufacturers

On December 7, 2023, Michigan Governor Gretchen Whitmer signed Senate Bill No 410. This bill repeals a 1995 law that provided immunity to drug manufacturers from product liability. Previously, the Michigan Product Liability Act (1995) exempted drug manufacturers and sellers from liability if the drug at issue obtained FDA approval and had compliant labeling. The only exception to immunity was if the FDA determined that fraud or bribery influenced the approval process – making it nearly impossible for Michiganders to sue big pharma.

For nearly 30 years, this law prohibited Michigan residents from recovering in state or federal courts for injuries caused by prescription drugs. Under the new law, this immunity is repealed. Michigan plaintiffs are now allowed to claim and prove a product defect.

Michigan Attorney General Dana Nessel celebrated the new law in a statement: "The Michigan Product Liability Act has been used for far too long to shield pharmaceutical companies from a ccepting responsibility when they knowingly defraud and harm the public[.] I applaud the legislature for finally addressing this one-of-a-kind bill that placed protections for large corporations over the safety of Michigan residents."

### RECIPE: Sizzling Stovetop Sticky Terriyaki Wings

This recipe is for 4 large wings but can be expanded to cook a large skillet full. Use about 2 tablespoons of sauce for every 4 wings.

### **INGREDIENTS:**

- 4 large chicken wings
- 2 tablespoons teriyaki sauce
- 1 fresh red chili pepper (optional)
- 2 green onions

### INSTRUCTIONS:

1. Put the wings into a hot pan – they should fit snugly. Brown them for about 1 minute on each side.

2. Add the teriyaki sauce and just cover the wings with water. I recommend Kikkoman Original Takumi Collection



Teriyaki Sauce because it is flavorful, thick, and infused with sesame seeds.

3. Add slices of red chili pepper or other favorite to the simmering water, if you like your wings spicy.

4. Cook until the chicken is cooked through and tender, and the sauce reduces and thickens.

5. Turn the wings and coat them in the sticky, teriyaki sauce.6. Remove the wings to a plate or bowl and add a splash of red wine vinegar to the pan to loosen and pick up the thickened sauce. Pour over the wings to fully pick up the goodness left in the pan.7. Top the wings with chopped green onions and gather a lot of napkins.

### Teenage Passenger Killed in Single-Car Accident When Driver Flees Police & Runs Stop Sign

Our client was the front passenger in his friend's vehicle at the time of this accident. Initially, the driver of the vehicle was signaled by police to pull over after the officer witnessed the vehicle traveling at a high rate of speed. While the police attempted to initiate a traffic stop for this speed violation, the driver failed to stop. As a result, the officer engaged in a pursuit, which was terminated just after a few minutes prior to this accident. Over a mile away from where the pursuit was terminated, the driver was still traveling at an unsafe speed when they failed to stop at a posted stop sign, causing the vehicle to veer off the right side of the road. Ultimately, the vehicle struck two trees before coming to its final rest. Our client was pronounced dead at the scene. Due to the recklessness of the driver, our client tragically lost his life at the young age of seventeen. Our office is pursuing a wrongful death action on behalf of the surviving family.

### Woman Resuscitated After Accident Ejects Her From Vehicle

Our client was T-boned by another driver, which caused our client's vehicle to turn over multiple times, crossing the median. As a result, she struck another vehicle in the opposite lane of traffic. This three-car accident led to our client being completely ejected from the driver's seat in her vehicle. The client was initially found to be deceased but was resuscitated shortly after the accident, leaving her on life support for an extended period. She suffered various other injuries such as fractures in her leg, pelvis, ribs, and various parts of her spine. Since the accident, our client has been receiving intensive care and underwent several surgeries. Miraculously, our client is at a point where she is currently trying to learn how to walk again. Our office is pursuing a negligence claim against the driver who T-boned our client.

### Man Severely Injured In Accident When Other Party Runs Red Light

Our client was traveling through an intersection and was suddenly struck by another vehicle that had just run a red light. At the time of this accident, our client was transporting patients as a part of his employment. Upon impact, both our client and the patient he was transporting suffered injuries. Our client sustained a fractured sternum, collapsed lung, phrenic nerve damage, and numerous other injuries that have required lengthy hospital stays and multiple procedures. Our office is pursuing both a workers' compensation claim and a separate negligence claim against the other involved driver on behalf of our client.
