Boyk Law Attorney Appointed to Plaintiffs' Committee in Ohio Train Derailment Case

Boyk Law's Wesley Merillat was appointed to the Plaintiffs' Steering Committee ("PSC") in the consolidated class action litigation involving the Norfolk Southern train derailment in East Palestine, Ohio.

On February 2, 2023, a Norfolk Southern train carrying hazardous chemicals derailed in East Palestine, sending plumes of toxins over the community, onto their land, and into their waterways. The derailment, which is one of the worst in history, ignited a massive disaster and has caused devastating impacts on human health and the environment. The litigation alleges that the train derailment and resulting chemical spill was the cumulation of years of the rail industry's efforts to cut costs, slash its workforce, and lobby against safety regulations.

In cases like this – where there are a significant number of suits filed and a huge number

of people and businesses impacted, Federal Courts can appoint a team of select attorneys to coordinate and lead the litigation and oversee the common interests of all the plaintiffs involved.

The U.S. District Court of the Northern District of Ohio considered attorneys with significant experience with complex litigation, and with

skills and knowledge to handle this type of litigation. "I am honored to serve alongside an esteemed group of attorneys, to work together on behalf of the individuals, businesses, and community members who have been injured and impacted by Norfolk Southern's dangerous negligence," said attorney Wes Merillat.

East Palestine Train Derailment Cases Move Forward



The Norfolk Southern train was carrying 100,000 gallons of ultra-toxic and dangerous chemicals when it derailed in East Palestine. The chemicals dispersed into air, soil, and water. First responders identified the potential of a catastrophic tanker

explosion and Ohio Governor Mike DeWine issued an evacuation order for anyone living within a mile of the derailment.

Norfolk Southern reported to Federal, State, and local governments that the only way to avoid a catastrophic tanker explosion was to conduct a controlled release and burn-off. They detonated explosive charges on these tankers causing them to spill out the chemicals into a trench and set it on fire. This detonation resulted in a large fiery explosion that formed plumes of thick black toxic smoke which filled the sky and rained down on people and property 30 miles in each direction, contaminating the air, soil, surfaces, and water of up to a half million people.

Area residents suffered personal injury, exposure to high concentrations of cancer-causing chemicals, had their property damaged and contaminated, businesses and jobs shut down. People, livestock, plants, crops, wildlife, water, and food supplies were affected.

RECIPE: Sunsational Summer Strawberry-Watermelon Lemonade

INGREDIENTS:

- 1/4 cup sugar
- 2 cups boiling water
- 2 cups fresh strawberries, hulled and quartered
- I medium-sized melon
- 1 12 oz can frozen lemonade concentrate, thawed
- 3 tbsps. lemon juice
- Ice cubes

INSTRUCTIONS:

1. Dissolve sugar in boiling water. 2. Place strawberries and watermelon in batches in a blender; cover and process

until blended. 3. Pour blended fruit though a fine-mesh strainer; transfer to a large pitcher.

4. Stir in lemonade concentrate, lemon juice and sugar water. 5. Serve over ice.

CASES OF INTEREST: JUNE 2023 Mother, Daughter, & Pets Rear-Ended Employee Trips Over A Metal Rod In

Bv Semi-Truck

Our client and her daughter were traveling on State Route 34 and had slowed to make a left turn when a semi-truck smashed into the back of their vehicle. Their vehicle was impacted with such force that the rear of their van folded up into the middle seat. One of our clients suffered significant injuries including multiple fractures in her spine. At the time of the accident, our clients had a dog and a hedgehog in the vehicle. Luckily, the animals were unharmed, but the supplies and cage were completely destroyed. Our office recovered reimbursement for their property and is seeking compensation for their medical bills and pain and suffering.

Parking Lot

Our office represents a woman who was walking to her car after leaving work when she tripped on a metal rod protruding from the surface of the parking lot. As she walked to her car, her shoe got stuck on the upright piece of metal causing her to fall face first. She injured her face and chest and fractured her elbow. Our office is pursuing a workers' compensation claim and an injury claim, seeking CASE FILE compensation for her injuries, lost wages, and pain and suffering.

Disabled Elderly Woman Dropped Off Transport Bus

Our client, an elderly woman in a wheelchair, was loaded into a medical transport vehicle so she could be transported to another facility. She was not secured properly and fell out of the back of the vehicle, onto the ground and landed on her back. Due to the fall, she suffered a brain bleed, multiple broken ribs, and a long hospitalization.
