## Boyk Law Cares About Lucas County Dogs

It's no secret that our firm loves dogs, especially the pampered Pawyers in our Holland office. We also care about the less fortunate dogs at Lucas County Canine Care and Control (LC4), and we are committed to helping them. Our Charles Boyk Law Cares program has made multiple monetary and equipment donations to the shelter. We purchased, built, and delivered 20 raised pet beds, that evenly distribute the dog's weight so that there are no pressure points on hips, shoulders, or elbows. The beds are easy to clean, but most importantly, the dogs don't have to sleep on the cold floor of a kennel.

With the help of clients and friends, we raised additional funds and collected donations of treats, and blankets to create holiday care packages for all of the shelter dogs which were hand-delivered by Boyk Law personnel on Christmas morning.

Our firm also beautified the adoption area of the Lucas County shelter. The Charles Boyk Law Cares Adoption Center at LC4 provides an attractive area where those who adopt
dogs can take photos with their new pups to share with family and friends on social media, and hopefully, encourage others to adopt LC4 dogs as well.

One of our Boyk Brief podcast episodes featured Kelly Sears, Director of Lucas County Canine Care and Control, and Anna Brogan, their Community Engagement Manager, who talked about their mission and the challenges they face.

Boyk Law shared news about the shelter and featured adoptable dogs via our social media channels to help more of them find a forever home.

Overall, more than a thousand dogs were adopted from the shelter in 2023 and almost nine hundred more were returned to their owners. LC4 also provided $\$ 104,000$ in emergency medical care to dogs in need.

The Charles Boyk Law Cares program will continue our support of Lucas County dogs in 2024 and also explore ways to help shelter

The Toledo area is at the northern edge of totality, where the moon will completely block the sun. Even residents of Sylvania and other nearby communities are outside the path of totality and won't be able to view the eclipse safely without protective glasses. Tourists from other areas are expected to visit Toledo to view this once-in-a-lifetime event which won't happen again in this area until 2099. RECIPE:

## Gregorio's Grilled Chicken Fajita Skewers INGREDIENTS: <br> - $1 / 2$ tsp. ground cumin <br> - 1 tsp. ground coriander <br> - Pinch of cayenne <br> - 4 tbsp. olive oil <br> - 3 limes <br> - 1 lb . boneless, skinless <br> chicken breast, cut into <br> 11/2-in chunks <br> - 1 lb . mixed-color <br> 

peppers, cut into $1-i n$. pieces

- 3 jalapeños, sliced about $1 / 2$ in. thick
- 2 small red onions, cut into 1 -in.-thick wedges
- salt and pepper
- 12 small flour tortillas
- Skewers (If using wood, soak them in water to avoid burning)


## INSTRUCTIONS:

1. In a large bowl, mix the cayenne, coriander, and cumin, with 2 tablespoons oil and zest of 1 lime. Add the chicken chunks and toss until all pieces are coated.
2. Season the chicken chunks with salt and pepper and thread onto skewers.
3. Toss the onions, peppers, and jalapeño pieces in 2 tablespoons of oil and season well with salt and pepper. Thread each vegetable piece onto its own skewer.
4. On a medium-high temperature grill, cook the chicken skewers for 8-10 minutes and the vegetable skewers for 4-8 minutes.
5. Cut the limes in half and cook face down on the grill for about 1 min until lightly charred.
Serve with tortillas, sour cream, cilantro, and shredded cheese.

# CASES OF INTEREST: MARCH 2023 

## Passenger Suffers Multiple Fractures When Other Car Knocks Them Off The Road

Our client was a passenger in the backseat of his friend's car when another driver suddenly smashed into the vehicle he and his friends were traveling in. The other driver had blown through a stop sign, while traveling at a high rate of speed, causing the two vehicles to collide in the intersection.

Upon impact, our client's vehicle was pushed off the roadway and struck numerous posted signs as the vehicle was shoved off the road. Our client suffered three fractures in his arm as well as other injuries and is being treated by an orthopedic surgeon. He has also been unable to work since the date of the accident. Our office is pursuing a negligence claim against the driver who T-boned the vehicle our client was traveling in.

## Minor Nearly Loses Fingers During Shop Class

Our client was working on a project in his high school construction class when he went to use the table saw that had a broken blade guard. Our client's teacher was aware of the broken blade guard, but still nonetheless permitted our client to use the machine. Our client was pushing pieces of wood through the machine when he was startled by another classmate and inadvertently moved his fingers toward the exposed blade. The blade nearly severed his index finger and cut off the top portion of his middle finger on his dominant hand. Our client required several surgeries and hospitalization due to his injuries. Before this incident, our client aspired to work in construction after graduation, but he will now face great difficulty even using his dominant hand for simple daily tasks. Our office is pursuing a negligence claim against the client's school.

## Woman Injures Bicep on the Job Due to Forklift Incident

While on the job, our client was positioned inside of one of her company's truck beds, organizing product, when a subcontracted forklift driver unloaded additional material while she was still inside. As a result, our client's arm was eventually struck by the forklift's prongs. The power of the forklift tore our client's bicep muscle. Our client has had one surgery so far and remains off work with a frozen shoulder. It was later learned that the day this incident occurred was also the forklift driver's first day on the job. Our office is pursuing both a workers' compensation claim on behalf of our client and a separate negligence claim against the employer of the forklift driver for their failure to properly train and supervise their employee.
